Reflective Function refers to one's intentional capacity to understand the meaning of our own, or our infant/very young child's thoughts, feelings, and reactions. Also referred to as "mentalization," a caregiver's capacity to engage in the act of "keeping the baby in mind" has been shown to impact the quality of caregiver-child interactions, as well as attachment security. 










COMPARISON OF EI ELIGIBILITY REASONS





EI EXITS BY MONTH






