Tepin kapehse

Peneinei en seri me iang towe (EI) ahneki pwuhng oh doareperail pato nan Individuals with Disabilities Education Act (IDEA).

Kempahn Seri oh me Pwulopwul (DCY) oh iengerail local partners kan me wia pwihn en Ohio EI system oh pwukoahki kapwulowei pwung oh doaropen aramas. Me tohto mekin apply mendahte me neirail serio dierekda mehsto konehng ale EI.

Doaropwe wet pahn soweisei komwi alehdi irehkan oahng pwung oh daorepemw oh pil dahnge me ke konehng en wia ni ansou meke pahn lel kasapwurupwur en EI. Doaropwe kan me doadoahk nan EI kawehweh pwung oh daorepemw kan ni pisetik. Pwehn kapatahieng, noumw EI service coordinator o pahn kawehwe dahkei mwo oh sapeng amw iren peidek kan koaros me ke anehki.

Pakair en Mwowe oh Mweimweida

Ke pahn alehdi rohng en soahng kan karos me pahn wiawi sang EY system mwohn eh pahn kin wiawi ni inting. Met me kahdahniki "prior written notice." Prior written nice wet pahn keing komwi ansou mwahu ken koasoanehdi make pahn oke de patehng kemwekid wet. Make men tapiada wia kemwekid wet ansouwohte, ke pahn kak en kasohrehla rahn akan me koasoandi ken awiawih. Mwurin ahmw koasoanehdier ken tepda, ke pahn intinghda ehu kisin likoun mweimwei.

Kisin likoun mweimwei wet adaniki "consent." Ahmw mweimwei pil kak en uhdi make solahr inangih en patehng. System en sapis en EI pahn udahn sapengela kalelapak karos meke anehki mwohn doahk wet ah pahn tepida. Melau kalelapak rehn noumw EI service coordinator o de emen sohte lipilipil me sousoweseiuk oahng irahkan koaros meke anahne ese. Prior written notice and consent kin ohng

- Petehk keneinei en mwomwen kekeirdahn seri;
- kosou pen seri;
- kosou pen peneinei oh serio;
- koasoandihn ma ke konehng ale; oh
- tapida de wekidala sahpsis kahng ohng Individualized Family Service Plan (IFSP).

Ke pahn alehdi kisin likou mwohn sahpsis sohte lipilipil me sansal pohn noumw IFSP oh eh pahn ididi de nek sang nan EI o.

Ekei me pwukat pahn kak en sohte daur ksisin likoun prior writtern noice o. Mweimwei udahn pahn anahne sang rehmw mwohn EY system e pahn kairala daadoahk kan.

El system udahn pahn anahne alehdi ahmw mweimwei mwohn:

- ehukieng audepen noumw serio oh peneinei oahng men liki kan, me pil kak en iangahki noumw toahktehn seri;
- ehukipene ehu rahn en tuhpene pwehn wiahda koasoandi; de
- doadoahngki noumw public de private insurance pwehn pwain sahpsis en EI kan.

E kesempwal ken ese me udahn pahn mie evaluation pahn wiawi pwehn kasawiada ma noumw serio kak en iang ale sahpsis kan me pahn sang EI system. Mah ke sohte mweidada noumw serio an ale kesou pwukat, noumw serio sohte pahn iang ale sahpsis kan me pahn sang EI system.

Kosou kesempwal kan me pid noumw serio me sohte me pahn iang kilang de ese

Pwehki EI system e kolokol audepen kowe oh noumw serio , a ke ahneki pwuhng en iang kilang records kan me pahn epwel pahn EI system. Rekerd pwukat me ianghaki audepen en noumw serio EI kan karos, iangahki audepen roson mwahu en serio oh eh kak kan ehn iang EI, sahpsis en IFSP , koapi de udahn doaropwe en EI kan meke oudehda oh sainla, oh daropwehkan karos me mie nan pwungen kowe oh EI provider o.

Ke ahneki pwung tohto ohng me pid rekerd en ahmw peneinei nan EI. Me pwukat me iangahki pwung en:

- peki koapi en rekerd en noumw serio ah EI;
- tehk tiki mwahu en noumw serio record en EI nan erein rahn 10 meke rikiweso;
- ale emen tohrohr pwehn iang tehk tiki rekerd en EI en noumw serio;
- alehdi kawehwehpen record en EI en noumw serio;
- ale soahng kan koaros de wasa EI rekerd kan mihmi ie, kin epwehpwel ie, de doadoahk ie;
- peki me ren wekidala mehkot nan nein noumw serio EI rekerd o; oh
- pil kak en alehdi due process eahring ma noumw provider o sohte wia dahme ke mwahuki ren wiahng nein noumw serio record en EI o.

Ke pahn alehdi (ni soh isais) koapi en ma ke kak nan erein rahn 5 en rahn en kemwekid, oh IFSP nan rahn 10 mwuring amwail tuhpene. Ke sohte pahn pwaind pweken ale noumw EI rekerd; ke pahn kak en pwainte arail pahn koapihda noumw EI record o oh pweipwei wet sohte pahn kak en elehda ken dehr ale noumw record o pwehken iang kasawih.

Pwehki ire kesempwal kei me pato nan noumr EI rekerd oh, aramas me wie doadoahk wasa me kolokol rekerd oh udahn pahn kolehdi oh sohte ehukieng ekis wasa. Wasah kan me apwalih oh kol noumw EI rekerd oh me pidada ahmw peneinei udahn pahn koledi soahngkan de wasahkan me EI wet alahdi sang ie oh apwalih. Irail akan me ahneki kak en ale ohng noumw rekerd o pahn ehukiengete irail akan me koasoandi ren iang kilang de (PII) oh mehteikan me koasoandi nan EI system oh peneinei me koasoandi. Make mwahuki noumw PII ren ehukieng mehn liki kan sang EI systmen, ke pahn anahne mweida mahs.

Ekei ansou irail Family Educational Rights and Privacy Act of 1974 (FERPA) kin mweidada noumw rekerd o en kasansalieng ekei wasahkan ni arail sohte ale mweimwei sang uhk. Wasahkan me duwehte:

- anahnepen IDEA oahng en noumw serio imwen sukuhl oh wasahkan nan kempahn kamarain me anahne. Met kan me oahngete audepen wasa ke kousoanie, eden noumw serio, oh rahn ah ipwidi.
- Pali kan me pahn anahn ren wia petehk ohng kempahn kamarain oh oh wasahkan me pahn tehk keirdahn noumw serio, wasahkan me pil kak en wia elen sawas ohng ni ah kamarain de pil isipen ah;
- sohte lipilipil en pali de aramas me pahn idihdasang Comptroller General of the United States, Attorney General of the United States, the Secretary of Education, de local oh state kempahn kamarain pwehn kak en wia kosou ohng serio pwehn sowese ohng nan pali kamarain sohte lipilipil kan
- pwihn ehu me kak en apwalih oh wia weliepe ohng wasahn sawas en serihkan me kak sang wehi de wasahn sawas akan oahng seri pwehn kak ale sawas epen serio; oh
- mwoalen kopwung ma pahn mie anahnepe sang rehral.
