## Pum Umtu sining Thanchonak lei caah Chekhlatak le Zohfelnak caah Tuan Deuh in Catialnak in Theihternak le Hnatlakpinak Tuahnak

The **developmental evaluation (pum umtu sining zohfelnak)** timi cu early intervention (EI) phu nih tuah asi tawn \_ zohfelnak ah a thiam bak mi minung pakhat silole cunak tam deuh nih \_ na fa cu hibantuk asi ko tiin ngandamnak-lei le sii-lei kongkau zehmanh a ngeih lo tik caan ah na fa cu EI riantuanpiaknak pek ding in aa tlakmi asiko tiin biakhiahnak tuahnak caah.

Kherhlainak/Zohcheknak tuahnak (**assessment**), cu aakhatmi caan ah tuahtawnmi asi, cu nih ati duh mi cu nan chungkhar nifatin nan cawlcanghnak le nan sining chung ah na fa nih zeitindah aa tel ve ti kha hngalh dingah asi. Zohfelnak le zohcheknak (evaluation) le kherhlainak (assessment) tuahnak chung ahcun atanglei bantu pawl an i tel:
