

INSTRUCTIONS FOR EISC TRANSITION CREDENTIAL HOLDERS

Transitioning to a 5 Year EISC/EISC Supervisor Credential

Overview

Individuals holding an EISC Transition or EISC Supervisor Transition credential will **not** renew their Transition credential. Instead, they will apply for a 5 Year EISC or EISC Supervisor credential.

Requirements

The requirements for individuals currently holding a Transition credential to obtain a 5 Year EISC or EISC Supervisor credential are listed below.



- Complete all Principles of Service Coordination (POSC) modules, or Test-Out exams, if applicable.
- Complete at least 50 hours of professional development during the most recent credential period (may include POSC modules, when completed instead of the Test-Out Exams).

Documentation of the 50 hours of required professional development must be reflected in the Professional Development tab. Applicants are required to complete the [CPD Tracker](#) form to indicate which trainings from their Professional Development tab they intend to count towards their 50-hour requirement. The completed CPD Tracker will be submitted alongside the application in the “Attachment” section.

Accessing the Application

Individuals holding an EISC Transition or EISC Supervisor Transition credential will follow the steps below to access a 5 Year EISC or EISC Supervisor credential.

1. Select the plus button beside “Applications” in the left-side navigation menu.
2. Select the plus button beside “Service Coordinator Credential”.
3. Select either “Early Intervention Service Coordinator – 5 Year” or “Early Intervention Service Coordination Supervisor – 5 Year”

- This application will not be available unless all seven modules of POSC modules, or the Test-Out Exams (if applicable), have been completed and marked as “Verified” in the Professional Development tab. - Individuals holding a Transition credential do not need to wait until they are within 90 days of expiration to apply for a 5 Year credential. As soon as they have met the requirements, they can apply for the 5 Year credential.
