Sahpris ohng irail akan me anahn tohror de me iang towe Individuals with Disabilities Education Act de IDEA, e wiahki mwekid ehu me Early Intervention (EI) sahpris kan pahn kin patohda ni soh isepe. Ekei sahpris me sang IFSP kan me rasehng aramas mere pan pilada pwehn wia soun kadokepenei kumwail oh sahpris tohror kei sohte pahn pweipwei sang komwi pweh pweipweidier sang koapwoarment.

Anahnepen kalaud de doudoulahn sahpris en EI¹ pahn kin koasoandihang irail semen kan en IFSP. Wen tohto en unit 100² ohng serihkan me pilipilda pwehn ale sahpris en IFSP wet,³ mendahte ia wen tohtohn arail ale sahpris wet e pahn sohte isepe. Sahpris pwukat koaros e pweipweisang dahkehnh koapwerment kan oh sang ni noumw insuranace meke mweidada.

Mwohn tepin tuhpenehn komwi oh IFSP, a aramas mere pilada pwehn soweseiuko pahn kawehweiang uhk mwomwen en Ohio koasaondi en pweipwei kan me sansal (ohioearlyintervention.org/federal-and-state-regulations) oh kumwa pahn tehkada me sahpris en EI kan pahn pweipwei nan ehu pahr mah tohtoh sang 100 unit de soh.

Komw sohte pahn pwukoahki pwain sahpris en EI.

- de mah mie pweipwei me daulihala udahn wen me konehng nan erein pahr ehu en IFSP.

Ma ke sohte lel koasaondi en pweipweikan me mie de pilada ken sohte ehukieng pwihn mwomwen wiepen ahmw pahn pwain, a ke pahn udahn pwaing sahpris en EI kan me pahn sipelehla unit 100 nan pahr ehu. Noumw soun sawas o de Service coordinator o pahn kehsekin komwi ia mwomwen pweipwei en EI oh pilipil kan me mie ke kak en wia ni ansou me IFSP wiwawi.

Ni ahmw iang wia kisehn pwihn en IFSP, ke pan sawas oh pilada menia sahpris oh wen sahpris kan me pahn anahn pwehn kak en alahdli pweidahn IFSP wet. EI ServiceCoordinator o pahn ehu oahng uhk pwehn koasoanehdi anahn en sahpris oh mwohni de pweipwei ni ansou me irail koaskoasoane noumw IFSP de wekideklah kan.

PWEIPWEI EN SAHPIS EARLY INTERVENTION

Soun sawas EI Service Coordinator o pahn kawehweieng komwi mwomwen wiepen en Ohio's System of Payments koasoandi (ohioearlyintervention.org/federal-and-state-regulations) oh pahn udahn kieng komwi noumw koapi ansou ke meke peki. Koasoandi wet pwakih mwomwen ahmw pan pwain sahpsis en EI oh mweimwei sang peneinei anahn mwohn sahpsis pwukat e pahn kohieng komwi.

Noumw EI Service Coordinator o pahn tehkada menia sahpsis me kak wiawieng noumw serio me sohte isepe, oh menia me kin pweipwei. Noumw EI Service Coordinator o pahn kawehweieng komwi me komwi me pahn mweidada ma e pahn private de public insurance me pahn pwain sahpsis kan oh pwuhng en ken pwurehng tehk sapahl dahme konehng kan oh mwomwen pweipwei kan me koasoandi.

Doadoahngki private insurance

Kalapw wiawi ni ahr pahn kadarehng ahmw wasahn daodaohk, palihkan meke iang towe, insurance kan me sohte sansal nan state of federal program kan me diwehte medicaid de medicare.

Ke pahn udahn anahne mweidada mwohn omwi pahn doadoahngki noumw pein insurens pwehn pwain sapis pwukat. Noumw EI Service Coordinator o udahn pahn kawehweieng uhk wiepe kan me mie oahng ma komw pahn daodaohngki private insurance pwehn pwain sahpsis en EI kan, met me iangahki sawas teikan me ke kin aliale de sawas akan me ekin aliale meh sohla ale soahng kan koaros me ke konehng en ese me pahn pidada pweipwei kan koaros pwehn dehr doulihla unit 100 ohng sahpsis en EI.

Ma ke naineki private insurance oh udahn koasoanehdi ni teng me ke sohte pahn pwukaohki sahpsis en EI, ke udahn sohte pahn pwaing co-pays de soahng kan me pahn dondolsang.

Noumw EI Service Coordinator o udahn pahn kin ale mweimwei sang uhk ansou karos me mie laudlahn pweipwei en sahpsis en EI ohng noumw IFSP.

Doadoahngki Public Insurance

Medicaid wia public insurance program ehu. Ni ansou meke iangher naineki Medicaid ke sohte pahn pwain sahpsis de soahng teikan me pahn pidada sahpsis en EI, de premiums, co-pays de deductibles en sahpsis en EI kan.

Doadoahngki Medicaid, sohte keper en meh pahn lopila ahmw men iang doadoahngki kamwahukan me sang medicaid, sohte keper en meh pan kak en nekila de titikla pweh wia pali ehu me poatoapoat makan iei iang de sahpsis kan udahn pahn duduhwete pwehn soweseiuk.

Noumw EI Service Coordinator o pahn ale mweimwei sang rehmw pwehn ehukieng Ohio Department of Medicaid momwen pweipweikan me pahn wiawieng noumw insurance o. Make mwiedada, ke pahn kak en pil sohla mweidada.

Doadoahngki Public & Private Insurance

Ma mie noumw pein oh an wehi insurens, ke sohte pahn pwukaohki pweipwei en sahpsis en EI kan.

Noumw EI service coordinator o udahn pahn ale mweimwei sang uhk pwehn kak en alehdi noumw private de public insurance kan mwohn arail pahn inda ken pwain sahpsis en EI kan.

Mehn kaweid de perehrehkang ohng komwi

Sahpsis en EI sohte pahn tokedi de lopila ohng serio ma:

- peneinei doadoahngki private insurance pwehn apwalih ki serio de pein pwain sahpsis en EI kan;
- serio de peneinei o daodaohngki public insurance program kan;
- de mweimwiedahn peneinei en ehukieng mwomwen serio-de soahng teikan me pidada public insurance programs.

Sahpsis en EI kan sohte pahn irehdi seri de peneinei ehu ren iang daodaohngki public insurance kan pwehn apwalih sahpsis sang EI, ahpw udahn pahn ehukieng pali wet soahng kan koaros me pidada program tei kan. Pali en EI wet udahn sohte pahn kapwukaohki public insurance program kan en pwain ma peneinei o de serio saik iang kileledi nan public insurance program kan.

Pwehn doadoahngki public insurance en serio de peneinei pwehn pwain sahpsis en EI kan, iet en EI wiepekan:

- Pahn alehdi mweimwei sang pahpa oh nohno pak ehute pwe irahn ehukieng pali soangkan karos me pali anahne ese me pid serio oahng public insurance metkan oahngete wiepen pweipwei;
- pahn pil kasalehda sansal oh ni mweimwei mehnia sahpsis en EI nan IFSP o me peneinei pwungki.

Ni ansou me sansal me peneinei sohte pahn kak en pwain, sahpsis koaros me sang EI me serio anahne udahn pahn wiawieng serio de peneinei ni sohte isais met me pil iangahki soangen sahpsis teikan me kak en daulihla unit 100 nan pahr en IFSP ehu.

Peneinei me pahn kak en pwain udahn pahn anahne pwain sahpsis kan koaros lel me pahn daulih unit 100, met me kak daodaohngki private insurance co-payments oh deductibles kan, pwehn kak en alehda pweida en nan IFSP, sohte pahn pwain sahpsis kan me koasoandi me soh isais sang EI.

Sohte isias en sahpsis pahn kapweilaudla ohng peninei sang ni udahn dahme koasoandi oahng sahpsis en EI (pweipwei koaros pahn tenek sang mwomwen peneinei oahng dahme sansalehr kan oh dahme pahn kaken pwerda sang sahpsis teikan).

Seri de peneinei me doadoahngki private insurance de public insurance sohte pahn ale siasi en sahpsis me pweipwei pahn lapalahsang wen me neirail insurens kan kak en apwalih.
